 KBOO.fm, live streaming, researches media influences, manages KBOO's social media, training volunteers and staff, works with Development director, training volunteers on how to edit and upload content on website. Also develops code for the website. Is working toward making the KBOO.fm website be a center for breaking news. Would also like to see KBOO work toward citizen journalism via KBOO.fm for 'news-tips' and creating a 'anonymous' news drop as well.
